CONDITIONS GOVERNING REPRODUCTIONS

1. The purchase of a photographic print or rental of a color transparency does not in itself carry with it the right to make a reproduction in any form. Copyright in all *photographs* remains the property of the Rose Art Museum, the living artist, or the artist's estate or legal representative, unless otherwise indicated.
2. The publisher is to provide the Museum 2 complete gratis copies of the publication in which the image is reproduced.
3. Reproduction is permitted only from prints or transparencies supplied or approved by the Museum. All color transparencies and negatives remain the property of the Museum.
4. The loan period for all visuals is six months. A written request for an extension must be submitted to the Museum if the image is needed for a longer period of time.
5. The image must be reproduced unaltered and in its entirety unless approved in advance by the Museum. The reproduction must not be cropped, bled off the page, printed on color stock or with colored ink. Nothing may be superimposed over the image. When a detail is used, the word "detail" must appear in the credit line.
6. The full credit line AS STATED ON THIS FORM, must appear in proximity to the image, or in the section devoted to photographic credits.
7. The Museum assumes no responsibility for any royalties or fees claimed by the artist, or his/her estate, on his/her behalf. Permission from the artist, their representative or their estate, must also be sought separately.
8. Permission is granted for one-time use as detailed on this form. Permission must be obtained separately in advance for each subsequent edition, reprint or redesign.
9. Permission is valid only for the individual, company, or institution to which it is specifically issued and may not be transferred, assigned, sold, or otherwise disposed of without the written permission of the Museum.
10. The Museum reserves the right to deny permission to reproduce an image from its collection to any applicant whose product is not acceptable to the Museum for any reason.
11. Failure to pay the required fees for reproduction means that permission has not been granted.
