## Committees - Faculty Members Elected by the Faculty

Faculty Committees - created by the faculty, faculty members are elected by faculty. Some committees include students and administrators as ex officio members. The President is ex officio member of all faculty committees. Unless stipulated otherwise, ex-officio members shall be voting members of committees.

Non-voting members of the Faculty shall include the vice presidents who are not otherwise voting members of the Faculty; administrators who serve on faculty committees; administrators who chair administrative advisory boards; professors, associate professors, assistant professors and instructors associated with The Warren Alpert Medical School (hereafter referred to as "the Medical School"), and the School of Public Health and having Clinical in their titles; professors, associate professors, and assistant professors having Practice in their titles; professors and associate professors emeriti; the Faculty Ombudsperson; officers of instruction with titles other than those required for voting membership, and such other officers of the administration as may be designated by the Faculty Executive Committee (FEC). Administrators who are also members of the Brown Faculty with voting privileges retain their title of voting members of the Faculty. P. 14

## Faculty Governance Committees

The faculty steering committee consists of seventeen members: the president, the vice president and provost, the chairperson of the educational policy committee, the chairperson of the graduate and research committee, the chairperson of the faculty compensation committee, the past-chairperson of the financial planning and operations committee, the senior (fifth-year) member of the faculty personnel committee, the chairperson of the faculty committee on student life, the chairperson of the faculty committee on global affairs, the chairperson of the faculty committee on advancement, the chairperson of the faculty committee for facilities planning, the faculty parliamentarian, the secretary to the faculty, and four faculty, one elected by each college faculty. The four college representatives will be elected to four-year staggered terms.
a. [Subcommittee on Rules and Procedures] (1.2.2.1.1)

The steering committee will have a standing subcommittee on rules and procedures, consisting of the four faculty representatives elected by the four colleges.
2. Educational Policy Committee (1.2.2.2)

The committee consists of nine tenured members of the teaching faculty, the provost, and the dean of each of the four colleges.
3. Graduate and Research Committee (1.2.2.3)

The committee consists of twelve elected faculty members, seven ex officio members, and four non-voting members.
4. Faculty Compensation Committee (1.2.2.4)

The committee on faculty compensation consists of nine members of the voting faculty
5. Faculty Financial Planning and Operations Committee (1.2.2.5)

The faculty committee on financial planning and operations consists of five faculty members
6. Faculty Personnel Committee (1.2.2.6)

The committee is composed of five tenured faculty members
7. Faculty Committee on Student Life (1.2.2.7)

The faculty committee on student life consists of 11 individuals: six faculty members, one elected from each of the four colleges plus two at-large faculty members; the Vice Provost for Student Affairs; the Associate Vice Provost and Dean of Students; the Director of Graduate Student Life; and two appointed student representatives, one each from the Undergraduate Student Senate and the Graduate Student Senate.
