## FINANCIAL AID & SCHOLARSHIPS



Brandeis supports qualified U.S. and international students with generous merit-based scholarships. Students are automatically considered for these scholarships when they apply. Additionally, U.S. citizens and U.S. permanent residents may apply for federal loans, and international students may be considered for Brandeis University loans.



Over 50% of admitted International Business School students received a scholarship in 2018.



Awards in 2018 ranged from \$5,000 to full tuition.
