

REPRODUCTION OF MATERIALS POLICY AND RELEASE

The Copyright Act of 1978 (17 U.S.C. secs. 101 *et al.*) provides statutory protection for all writings from the dates of their creation, whether or not they are formally published or copyrighted. It is the responsibility of the researcher to obtain permission for the publication and commercial use of material not clearly in the public domain, as penalties for violation of this statute are severe.

1. Copying, by any means, of copyrighted material made without the permission of the copyright holder is restricted by federal law in accordance with “fair use” standards as specified in the Copyright Act.
2. Copying of materials such as correspondence, papers and photographs from manuscript collections is allowed only with the permission of the University Archives & Special Collections Department.
3. Copying of academic department or administrative office files is allowed only with the permission of the University Archivist.
4. Publication (including social media) and/or commercial use of copies is prohibited without the prior written permission of (a) the University Archives & Special Collections Department and (b) the owner of the literary rights. *Any permission granted by Brandeis University applies only to the extent of its ownership rights in the materials, and does not constitute and may not be substituted for permission from the owner of the literary rights, which is the direct responsibility of the user to obtain. The user is solely responsible for the use of the material, and may need to obtain other permissions for the intended use of the material.*
5. Unless otherwise explicitly stated to the contrary in writing, Brandeis University does not confer an exclusive right to publish an item by granting permission to publish a copy of an item.
6. Limited photocopying and photographic services are available upon request. The Brandeis University Libraries reserves the right to refuse to copy an item if such copying may damage the material or violate any Brandeis University policies and restrictions.
7. Charges for reproduction, handling, mailing and other related services are borne by the applicant. A one-time use fee will be charged for each specific project. Further use of a copy or copies for another project or purpose requires a new application for permission and payment of additional fees (see **Fee schedule**).
8. Photocopies, photo-reproductions, and other materials may not be reproduced, altered or deposited without the prior consent of the University Archives & Special Collections Department.
9. The following credit line (as applicable) must appear in each publication of material from a copy or copies obtained from the following collections:

10. A complimentary copy of any published work or compilation in which materials from the Brandeis University Library were used may be requested by the Archives & Special Collections Department for deposit.

By signing this form, I acknowledge that I have read the above statement regarding copyright and acknowledge my responsibility to observe the above rules and further acknowledge that a violation of these rules will serve as a cause to prohibit my continued use of the Archives & Special Collections Department. I assume full responsibility for any and all legal action resulting from my use of the materials. I agree to indemnify and hold harmless Brandeis University, its officers, employees and agents from and against all claims made by any person asserting ownership of the common law copyright or literary property.
